### Appropriate engineering controls

Provide adequate ventilation. Avoid inhalation of vapours. Observe any occupational exposure limits for the product or ingredients.

### Eye/face protection

Eyewear complying with an approved standard should be worn if a risk assessment indicates eye contact is possible. The following protection should be worn: Chemical splash goggles or face shield. Personal protective equipment for eye and face protection should comply with European Standard EN166.

### Hand protection

Wear protective gloves. To protect hands from chemicals, gloves should comply with European Standard EN374. It is recommended that gloves are made of the following material: Nitrile rubber. It should be noted that liquid may penetrate the gloves. Frequent changes are recommended.
